



## NOTICE OF VOTE TO: MEMBERS OF MIAWPUKEK FIRST NATION

TAKE NOTICE that a Ratification Vote shall be held in accordance with the Miawpukek First Nation Community Ratification Process to determine if Eligible Voters approve the Miawpukek First Nation Land Code and the Individual Agreement.

The following question will be asked of the Eligible Voters of Miawpukek First Nation by ballot:

“Do you approve:

- The *Miawpukek First Nation Land Code*, dated May 23, 2017; and
- The Individual Agreement with **Her Majesty the Queen in Right of Canada?**

**Advance Polls** for the Ratification Vote will take place on Monday, September 25th, Tuesday September 26th and Wednesday, September 27th, 2017 from 1:00 p.m. until 5:00 p.m. at:


